# 2017/9397 NEW FOREST NATIONAL PARK AUTHORITY RECREATION MANAGEMENT STRATEGY REVIEW

I have previously made an announcement about the current consultation on the National Park's recreation management strategy. The Verderers and other Forest organisations, including the Forestry Commission and Hampshire County Council, asked the National Park Authority to lead on this important matter. This is a vital issue that is being debated and once again I encourage as many people as possible to give their views and in doing so put the Forest first in the hope that it will be protected for generations to come.

# 2017/9398 WATER FOR FOREST STOCK

At our last court we received a presentment from Mary Gray about the well-intentioned, but potentially dangerous action of putting out buckets of water in periods of hot weather for the ponies.

I reiterate what I said in a recent press release, namely that there is plenty of natural water available on the Forest even during dry spells. In addition there are a number of strategically placed water troughs maintained by the Verderers. Putting out buckets of water attracts stock to the roadsides thereby increasing the risk of accidents and I would urge the public not to do so.

# 2017/9401 PANNAGE SEASON 2017

In accordance with the provisions of Section 7 of the New Forest Act 1964, the Verderers have been consulted with regard to the dates of the pannage season and I hereby formally notify the Court that the season will commence on Monday 11 September 2017 and that it will end on Sunday 12 November 2017, both dates inclusive.

May I remind Commoners who hold the right of Common of Mast that:-

- 1. Pigs turned out must be levant and couchant in and upon the land from which the right is derived.
- Pigs may not be turned out until they have been inspected by an Agister, effectively ringed, marked and the appropriate fee paid. This must take place during normal working hours. 48 hours notice must be given and the time and place where the pigs are to be inspected and marked must be agreed.
- 3. Pigs must be marked before they are put onto the Forest.
- 4. Pigs may not be turned out into the Inclosures.
- 5. Breeding sows, that is female pigs in-pig, may be allowed the privilege of remaining on the Open Forest after the end of the pannage season if so authorised in writing by the Deputy Surveyor for the period specified in the consent.
- 6. Any breeding sow that is granted the specific written consent of exercising the privilege must be inspected, ringed, marked and paid for during the pannage season.
- 7. Any breeding sow exercising this privilege must return to the holding at night.
- 8. Apart from the aforementioned privilege of turning out breeding sows with proper authorisation onto the Open Forest beyond the pannage season, no pig will be allowed to remain on the Forest after the end of the season.
- 9. No period of grace is allowed for the removal of such unauthorised pigs.
- 10. Any consent granted for the exercise of the privilege is limited to the period following this particular pannage season and cannot be presumed to apply for future years, for which a separate application must be made.
- 11. Any unmarked animal running on the Forest does so in contravention of the Verderers' Byelaws and the owner is liable to a fine of up to £200.00.
- 12. Property owners of land adjacent to the Forest are reminded that it is their responsibility to fence out Forest animals from their land.

POSSIBLE DEVELOPMENT OF WHARTONS LANE FIELD, ASHURST

Presentment by Mr Graham Baker on behalf of the New Forest Association's Planning Committee

'The South Hampshire built up area is the UKs 7th biggest. Bigger than Tyneside and marginally smaller than Liverpool. (2011 census)

Within the National park and only 320 metres away at its narrowest point is the development boundary of Ashurst village at Foxhills.

The Parish consider it essential for its good and the good of the Park that this strip of traditional pasture on the edge of the National Park to east of the village remains entirely free of development. It accepts it has a duty to defend the NE frontier of the Park.

As part of the review of the Local Plan, the National Park Authority consulted on a list of potential housing sites. Included in these was a field to the east of Village boundary off Whartons Lane. This site has traditionally been used as back up grazing.

In the hope of avoiding building on this field, the Parish researched other possibilities and with some persistence discovered that much of Ashurst hospital site would soon become redundant and in the National Park Authority's second consultation document this site was included, but the Whartons Lane site was not withdrawn

We then discovered the Court had an interest in the land at the hospital site.

My purpose in coming here today is to ask the Court to do all it can in any negotiations on the hospital site to ensure that if it is redeveloped it is in place of and not in addition to the Whartons Lane site.

YOUNG COMMONERS REPORT – TRAILER TRAINING GRANT 2016-2017 Presentment by Lyndsey Stride

'Good morning Official Verderer, Verderers and members of the public.

My name is Lyndsey Stride.

We would like to thank the Verderers for their continued support of the Young Commoners Trailer Training Grant Scheme.

The scheme continues to support young commoners in carrying out their commoning responsibilities independently of their family and friends.

In 2016 we allocated £2,460 to four young commoners who successfully passed their trailer towing tests. In 2017, we have allocated £3,749.20 to six young commoners with an additional five approved for funding.

The Young Commoners group continues to meet regularly to discuss the issues affecting them and the wider Forest, providing both training and opportunities to share their views. Our most recent event was a walk entitled 'My Haunt'. Commoners have a deep knowledge of their own small patch of Forest and it is important that we share our knowledge with others. We all love to walk in the Forest and our busy commoning lives often mean that we rarely wander from our own area. We all learnt a few interesting facts about Rockford Common and enjoyed an excellent discussion over Fish and Chips back at the holding.

We are also keen to develop stronger relationships with the Verderers and other Forest organisations to ensure the needs and opinions of young commoners are carefully considered.

**ENGLAND COASTAL PATH** 

Presentment by Mr Brian Tarnoff, Habitat & Landscape Committee, NFA

'Legislation has mandated the England Coast Path, which in other regions may provide useful alternative recreation, pleasant views and tourist destinations. For the New Forest it will invite more disturbance into our most precious coastal habitats, a nearly uninterrupted series of highly designated and protected zones of international importance.

There is no funding for mitigation and little regard for infrastructure; some stretches, near or on small country lanes in the most remote parts of our coast, precisely where we wouldn't want to exacerbate the verge parking problem.

The Ordnance Survey will show the entire "coastal margin" (the entire seaward side of the path) as "access land", without delineating exclusions. As the route is likely to be significantly inland and much of our coast will be excluded for habitat protections, this depiction will be grotesquely inaccurate. Arguments will be had with visitors assured by the allegedly definitive map that they (and their pets) may trespass on bird nesting grounds regardless of what the signs say. The Ordnance Survey should restrict their illustration to the route of the path itself, and only show coastal access land as it unambiguously exists now at Calshot, Lepe Country Park and other similar extant areas.

Unfortunately these problems will be pertinent wherever it may be proposed, and we expect the consultation on the Lymington to Calshot route from Natural England later this month. We hope the Verderers will help press the case with the Ordnance Survey and will resist the worst excesses of this arbitrary unnecessary exercise which will bring not a jot of benefit to the Forest'.

# 2017/9408 CRAB HAT INCLOSURE FENCE Presentment by Mr Brian Ingram

Mr Ingram complained about the terrible state of the fence around this inclosure. He said it is constructed using high tensile wire and when he was an Agister he had trouble there. Posts are broken and the wire is down and now covered in vegetation making it extremely dangerous. Part of the fence is used during the drift to guide stock. The problems have been reported on many occasions but nothing has been done.

In addition, from Kings Hat Inclosure, upsides to Crab Hat and Dibden, a lot of damage has been done to the track by vehicles removing timber. Signs were put up saying the track would be repaired when the weather permitted. Nothing has been done. The ruts are 18" to 2' deep in places.

Mr Deakin reported that a commoner whose cattle graze on Penn Common has now lost 10 animals to suspected bracken poisoning. Tests are being carried out by the National Trust (NT) and the CDA to try to ascertain whether the cattle are being poisoned via water contaminated by run off from bracken stands in Foxbury Plantation, or through eating bracken plants. The cattle have been taken off the Common for the time being and the commoner proposes to provide a water trough outside his gate when his animals are turned back out. Other commoners with cattle in the area have not suffered a similar problem. Results of the tests will be available in due course.
