If an Agister is asked to mark any animal whose condition gives cause for concern, he will decline to do it until the animal has improved.

Several ponies and a few cattle have been reported with long feet. It is thought the very wet winter is probably responsible.

## 2018/9920 NATIONAL GRID'S PROPOSALS UNDERGROUNDING OF HIGH VOLTAGE POWER LINES IN THE NORTH OF THE FOREST

## HALE PURLIEU

At our last court Peter Gear, a resident of Hale, made a presentment about the National Grid's proposals for under grounding the high-voltage power lines which cross the north of the Forest.

Whilst the Verderers have been represented on one of the Stakeholder groups liaising with National Grid on this proposal, the Verderers have not yet received any formal, detailed, application for consideration.

The Verderers support in principle, proposals which result in the placing underground of unsightly and intrusive cables. However, the Court looks carefully at the details of any proposals and often has observations and indeed reservations about the details. Its consent is therefore by no means to be taken for granted, nor indeed is the National Grid so doing.

The Verderers continue to participate in discussions about this proposal and will continue to listen carefully to what is said, both in favour and against the proposal. It is of course open to both supporters and objectors to make presentments to this court if they wish to do so.

## 2018/9921 FOREST FARMING GROUP

The Forest Farming Group consists of representatives of the following organisations within the forest:

The CDA, National Park Authority, NFU, CLA, Forestry Commission, Natural England and the Verderers.

The Group's purpose is to secure future funding for the Forest on the expiry of the current HLS agreement in February 2020. In particular, we are seeking ongoing support for commoning because of course the Verderers' Grazing Scheme is funded by the current HLS.

The Group is actively lobbying both politicians and civil servants to make a case for the Forest to have a further bespoke scheme. We believe that our efforts are being favourably received but the current state of Government policy does not enable me to report that there are any concrete proposals for future funding.

In view of the state of Government policy, we have suggested that the current HLS scheme should be rolled over for a further two years to allow the Government time to formulate detailed proposals for areas such as the New Forest.

I'm sure you will all have noticed the emphasis placed by Mr Michael Gove, Secretary of State for Environment, Food and Rural Affairs, on assisting financially, those who provide environmental benefits and what is referred to as 'natural capital and public benefits'. The Forest Farming Group believes that the Forest provides these in abundance. Nonetheless we need to be able to articulate this and the Group is currently working on a paper which will draw together all the relevant facts and arguments supporting our case.

I hope to be able to report more progress in the coming months.

## 2018/9922 RECREATION MANAGEMENT STRATEGY

The process of updating the way in which recreation is managed in the Forest has now reached the next stage. Consultation has begun on a series of proposed actions that have been developed following last year's consultation. Everyone is invited to comment on draft plans to both protect the Forest and cater for residents and visitors enjoying the area.

We are all well aware of the harm that excessive recreational pressure has already caused to the Forest and, if steps are not taken now, that damage will only increase.

If they are not well managed, activities such as walking, cycling, horse riding, camping and vehicle parking cause damage to the very places that people want to enjoy.

Over time the harm that is caused includes:

- Erosion of paths and grazed verges
- A reduction in the tranquillity of remote areas
- Increased litter
- Interference with important Forest management such as commoning and forestry operations
- Erosion of sensitive habitat
- Disturbance of rare breeding, feeding and roosting birds
- Impacts on other rare and threatened species such as wild gladioli, smooth snakes and southern damselflies.

It is vital that we now find ways to work together to encourage and enable people to enjoy the Forest and nearby areas in ways and in locations that minimise these negative consequences.

The second stage of the Future Forest consultation runs for eight weeks from 18<sup>th</sup> June to 12<sup>th</sup> August.

The consultation and online survey have been developed by the Recreation Management Strategy Steering Group which comprises the Forestry Commission, Verderers, National Park Authority, Hampshire County Council, Natural England and New Forest District Council. Eleven other groups and organisations on the wider Recreation Management Strategy Advisory Group have also had an input.

With the help of feedback received in a first round of consultation last year, seven distinct objectives for managing recreation in the New Forest have been identified:

- Convey the things that make the New Forest special to both visitors and local people in more consistent and effective ways, so that they understand the importance of making responsible recreation choices.
- Address significant and/or widespread negative impacts caused by recreation in the most appropriate, proportionate and effective ways.
- Reduce the barriers that limit participation in beneficial outdoor recreation among those who need it most.
- Achieve a net gain for the New Forest's working and natural landscape and for the recreational experience, by influencing where recreation takes place.
- Increase the level of funding available for recreation management so that it is sufficient to address both existing and upcoming needs.
- Collate data and evidence to help inform the ongoing management of recreation.
- Regularly review progress against agreed recreation management actions and adapt forward plans to protect the special qualities of the National Park and enable people to enjoy and benefit from them.

The steering group is asking for views on how to put these into practice with a set of 25 draft actions.

- 18<sup>th</sup> June to 12<sup>th</sup> August 2018 Public consultation on the draft actions
- Autumn 2018 analysis of responses
- Early 2019 publish Recreation Management Strategy update with lead organisations for agreed actions
- 2019/2020 progress with actions.

It is vital that as many people as possible participate in the process and I urge you to do so and Put the Forest First in your answers.

## 2018/9923 ROAD ACCIDENTS

Earlier this month, hit and run RTAs resulted in two foals being left lying badly hurt on the road between Sway and Brockenhurst by drivers who failed to report the collisions.

We are concerned that there is a misconception amongst some drivers, that if they report an accident with a Forest animal they will face prosecution, a fine and points on their licence. We would like to stress that this is generally not the case. The only time a driver may find him or herself in trouble with the law is if there is evidence of careless or dangerous driving and that rarely happens.

Conversely, a driver who fails to report an accident and is subsequently identified will be very lucky not to end up in Court on the grounds of failing to stop and report an accident and causing unnecessary suffering.

The cost to the motorist involved in accidents with Forest stock is usually limited to the value of the animal and the disposal fee if the animal dies, possibly vet fees if the animal survives but needs treatment and the repair of the vehicle. The driver's insurance premium may also of course be affected by a claim, but some drivers choose not to claim on their insurance. Nothing prevents a driver from compensating the owner of the animal direct.

The law states that drivers MUST report RTAs with livestock to the Police as soon as reasonably and practicable possible.

Whilst on the subject of hit and run RTAs, we would like to remind everyone that the reward for information leading to the conviction of a driver involved in a hit and run accident with a commoner's animal has been increased to up to £5,000 and you don't have to appear in person to collect your reward.

#### ANIMAL ACCIDENT REPORT

### 2018/9924 THE ANIMAL ACCIDENT REPORT FOR MAY 2018

The Agisters attended 11 accidents in May, the same number as in May last year.

1 Pony was killed, 3 ponies and a sheep were injured and destroyed, 1 pony and a cow were injured, a pony was uninjured and 2 ponies and a cow which were reportedly involved in accidents could not be found.

6 accidents occurred in daylight, 2 at twilight and 3 in the dark.

4 accidents were not reported by the driver involved. 4 motorists were known to be local.

The total number of commoners' animals killed and injured so far in 2018 is 29. This compares with 25 in the same period last year.

Presentment by Mrs Margaret Verdon JP

'Good Morning Official Verderer and members of the Court.

I am Mrs Margaret Verdon JP. I have lived in the Forest for nearly 50 years. I have cycled all my life, but I am now unable to walk with my dog down narrow country lanes. When my dog hears a car, he tucks himself in beside me. However, we do not hear the silent cycle who came up fast behind us, shot by with no thanks and makes me feel rather shaken. Cyclists have earned a bad name (rightly so) for their lack of consideration towards other road users, in particular horse riders and pedestrians.

Could the Verderers promote a code of practice to encourage cyclists to behave better and in particular, to warn horse riders and pedestrians of their approach? To slow down and give a warning of their approach by ringing their bell or calling out "I am behind you".

NATIONAL GRID'S PROPOSALS UNDERGROUNDING OF HIGH VOLTAGE POWER LINES IN THE NORTH OF THE FOREST

Presentment by Mr Peter Gear, Resident of Hale and part of the Project Hale Purlieu Movement.

'My name is Peter Gear, resident of Hale and part of the Protect Hale Purlieu movement.

I would like to thank the Verderers for their response to my presentment at the May open Court. I would also like to thank them for taking the time to be present at our open meeting in Hale on May 22<sup>nd</sup> and to have read our paper objecting to National Grid's proposal to bury the electricity cables under the Purlieu. We fully understand the Verderers' position on this subject as we all await the planning application in December.

I would like to take the opportunity to state that there is a groundswell of opinion in the village and surrounding villages that National Grid's plans will cause irreparable damage to the landscape, the wildlife and the unique commoning practices. The proximity to the new Franchises Lodge RSPB reserve also gives rise to potential conflict during the long period of major disruption.

I trust that the Verderers will take into account the strong feelings expressed by local residents when making your final decision on this matter'.

WOOTTON STREAM RESTORATION PROJECT

Presentment by Mr Ian Davis, New Forest Equestrian Association

'I make this presentment as Chairman of the New Forest Equestrian Association.

We are extremely concerned about the Wetland Restoration Programme currently being undertaken at Wootton.

I would say that I have been able to meet members of the Forestry Commission several times on site and have been met with the utmost courtesy on each occasion.

However, first, we question the need for what amounts to an effective destruction of parts of the Forest, its trees, and plant life. We accept that the current stream was straightened a hundred years ago, but it until recently it afforded a solid safe stream bed, easily accessible access paths and safe crossing points for not only the horse rider but also depastured animals.

Secondly, if the works are to progress, we would ask for confirmation that all materials are locally sourced, are tested for their compatibility with the highly protected area and are not brought in simply on the basis of the cheapest available.

Thirdly, whilst we are glad to note that parked construction vehicles now have drip trays placed under them, we are concerned about the environmental damage caused by leakage of oils and hydraulic fluids whilst the vehicles are in use.

Fourthly we are concerned about the danger to horse riders. The old stream bed was perfectly safe and the underpasses under the road leading to the A35 from Wootton Bridge, marked as bridleways on the OS map were easily useable and accessible. Now horse riders are finding the stream and access points potentially dangerous and therefore unusable. Clay holes have been opened and one rider has had her horse trap a foot in a clay hole.

A part of the Forest riding area, open all the year round save in the most inclement weather has been has been rendered difficult to use and potentially unsafe.

I would ask that members of this Court who have not inspected the works do so and ensure that once the latest work phase has been completed in accordance with the planning consent, the stream and it's crossing points are safe for riders and depastured animals.'

#### 2018/9960 MARKING OF 'GHOST' CATTLE

DISCHARGE

A discussion took place regarding whether the Agisters should spend time marking cattle that may never go out onto the Forest. Some commoners are believed to be taking advantage of the Basic Payment Scheme which requires them to have a marking fee receipt in order to claim their common land subsidy. However, the Rural Payments Agency has no mechanism for ensuring animals for which common entitlement is claimed, ever actually run on the Forest. The result is that the animal numbers are artificially high, leading to the belief that there are significantly more animals on the Forest than there actually are.

The Court felt that to accept a marking fee and issue a receipt without the Agisters physically marking the animals is not acceptable.

FRANCHISES LODGE ACCESS TO THE FOREST AT BRAMSHAW TELEGRAPH

RESUME

Mrs Westerhoff said she has been invited to meet with the Warden of Franchises Lodge which has recently been acquired by the RSPB. Mr Dowsett expressed an interest in joining the meeting.

The Clerk asked Mrs Westerhoff and Mr Dowsett to discuss with the Warden, the ongoing problems that are being experienced with the access to the RSPB's land at Bramshaw Telegraph. The track which is a designated BOAT has a gate on its boundary with the Forest which is frequently left open. As a result Forest animals are able to access Franchises Wood and the adjacent Hamptworth and Lyburn Estates and from there onto public highways outside the Forest. Over the years, the Agisters and local commoners have spent a huge amount of time locating and returning animals to the Forest. The Clerk has already spoken to the RSPB Warden about the problem but she asked if the matter could also be raised at the forthcoming meeting. A solution to the problem will not be easy to identify. A cattle grid is an obvious option, with a bypass gate for walkers, riders and carriages, but cattle grids need continual maintenance if they are to be effective and they are expensive to install.
