# THE ANNOUNCEMENTS & DECISIONS BY THE OFFICIAL VERDERER, RTA REPORT AND PRESENTMENTS were published on the Verderers' Website after this meeting.

## 2020/11271 HAMPSHIRE COUNTY COUNCIL HIGHWAY FENCING

Mr Vanderhoek made a presentment regarding the poor state of much of the Forest's highway fencing that is the responsibility of Hampshire County Council.

In particular, he drew the Court's attention to the fence along the A337 opposite the Cadnam Cricket Ground in Shave Wood. This has now been repaired.

The Verderers and others regularly report to HCC, areas of fencing that need attention. As Mr Vanderhoek rightly says, there is quite an extensive list of fences that require attention. Concerns about the state of highway fencing and the lack of a rigorous inspection regime have been raised with HCC on a number of occasions in recent years. It seems that the financial constraints under which HCC operates means that whilst urgent repairs do get dealt with, albeit not always expeditiously, there is little prospect of a wholesale renewal using the type of fencing that has been erected along the A31, or of regular inspections.

In the meantime, reports of inadequate fencing will be made and followed up wherever possible.

# 2020/11272 PONDHEAD - RESPONSE FROM FORESTRY ENGLAND TO THE POINTS RAISED IN MRS TEAR'S PRESENTMENT

I am grateful to Mrs Tear for raising this matter with us. As the events took place in 2018 investigating what happened, and why, has taken some time. We have worked closely with Forestry England to provide the answers to the questions raised in the July presentment.

1. to confirm that FE's stated "standard practice" is for top soil and stream beds, NOT peat bogs.

The June response to the Presentment of 20 May 2020 included a method statement for avoiding over-compaction of soils along a machinery access route, where top layers of soil are moved to one side during working practices. This was incorrectly described as 'the standard practice when working in a wet area'. Forestry England's standard practice for wetland restoration projects is to use low ground pressure tracked excavators, rubber tracked dumpers and bog mats (where the ground is particularly wet). If the ground is too wet or heavy rain is forecast, its standard practice is to postpone or suspend work until ground conditions are suitable, to ensure habitats are protected from unnecessary damage.

2. to explain how Natural England's (NE) very clear operational plans to improve the SSSI unit's status, which appeared to be understood and shared by Forestry England (FE) in 2015, were ignored on site in 2018?

The stream restoration works in this area (SSSI Unit 387 – Matley Inclosure Bog) were carried out to improve the condition of the adjacent riverine woodland habitat, which was negatively affected by an over-deepened channel and associated spoil banks. By restoring meanders, raising the level of the stream bed and removing associated spoil banks, the project aimed to increase seasonal inundation and improve interaction with the floodplain.

Natural England's written response to the planning application, dated 10 May 2016, was supportive of the work and stated: "The proposal will deliver benefits to the site (SSSI units 386 and 387 in particular) reversing the effects of artificial drainage."

Forestry England and its contractors take their responsibilities seriously when carrying out wetland restoration works in the New Forest. Before work started at Pondhead, Forestry England had planned to use the south side of the stream for access in SSSI unit 387. However, conditions were extremely wet along parts of the south bank during the works in 2018. Forestry England and its contractors reassessed the options for an access route and made a decision to access the site through the riverine woodland along the north bank of the stream avoiding known features of ecological and archaeological interest. Once the access route on the north bank had been agreed work continued. During a subsequent site inspection visit by the FE officer it became clear that there was ground damage occurring and work was stopped. Unfortunately, by that stage damage to the wetter soils had occurred. After investigating the issues raised in this Presentment, Forestry England acknowledges that its standard practices were not followed in full on this occasion. Notwithstanding the factors present at the time, machines should not have crossed the areas of wet peat soils on the north bank of the stream. Forestry England is reviewing its operational procedures before any subsequent work takes place to ensure this does not happen again.

3. to ensure that FE not be allowed to return to this site to do anything unless or until they specify what and how they are going to access the site and carry out 'repairs" – no more heavy plant in the SSSI Unit bog please!

Any further work carried out at this site will be planned carefully to ensure that no machinery crosses the wet peat soils on the north bank of the stream.

4. to specify under which form of contract these jobs are let between FE and the contractor?

Framework agreement and call-off contracts. The framework agreement is based on the NEC3 Engineering and Construction Short Contract (April 2013).

5. provide FEs officers' daily notes on their interaction with the contractors, (particularly those which give consideration to the bog or NE advice)

A PDF version of available notes is attached (names of individuals have been redacted to comply with GDPR) covering 30/07/2018 to 31/08/2018. Despite searching and having spoken to the relevant officer (who left Forestry England in 2018) Forestry England cannot find any notes either stored electronically or manually from the first week in September.

6. please confirm whether the Verderers who visited the site and found no "cause for concern" saw the gouges out of the new re-meanders, and the newly arrived gravel banks that have pushed off the now exposed pink clay plugs, each of which were clearly visible at the time of their visit? I assume these are what FE wish to return to repair. Visiting the site alone without knowing how it was beforehand is a waste of time

The Verderers who visited the site did indeed notice the matters mentioned in this question. They considered that these were the type of issue that can arise following a restoration and would be satisfactorily remedied through the 'snagging' works which were already planned to take place.

7. to invite Peter Greenslade of NE who was familiar with the site, or an independent, fully qualified ecologist to assess the site

Peter Greenslade no longer works at Natural England. We have appointed an independent ecologist, Neil Sanderson, to assess the site (part of SSSI unit 387). The assessment included identifying the habitat types present along the northern (left-hand) bank of the stream, assessing how the habitats are responding to the stream restoration, and assessing

whether the stream restoration works – particularly machinery movements through the woodland and the placement of hoggin – have caused irreparable damage to the SSSI. The main findings were as follows:

Q1: what habitat types are present along the northern (left-hand) bank of the stream?

Q1 Answer: the north bank of the stream supports a complex floodplain and mire habitat, with twin influences from a strong springline rising on the northern edge of the floodplain, with highly acidic water and flooding from the river, with much less acidic water. This restricts Riverine Woodland habitats proper, with Alder and Ash on alluvial gley soils to a narrow better drained natural levee along the river. The bulk of the floodplain has developed soft wet peat soils fed by the springline to the north. This supports three main vegetation types. There is Aldermoor (the local name for Alder dominated wood on peat), with transitional vegetation from Riverine Woodland to Bog Woodland where the influence of winter floods leads to less acidic vegetation. Further from the river this is succeeded by much more acid Bog Woodland, presumably away from the influence of flooding stream water. Finally, there is a strip of open Valley Bog vegetation along the springline. Due to past coppicing the woodland supports a limited county value lichen assemblage typical of disturbed young growth woodland in the New Forest, as found in the 19th Inclosures.

The complexity of this part of site is not fully described in the Biodiversity Statement (Heath, 2015), with the existence of extensive peat deposits and the Bog Woodland and the associated transitional Aldermoor not described. The scoping survey of the lichen interest over states the lichen interest as a common epiphytic lichen was miss-recorded as a Vulnerable Red List species. Off the area of survey upstream the descriptions of the grassland oddly refer frequently to semi-improved grassland where there are actually rather species rich typical New Forest grasslands.

Q2: how are the habitats responding to the stream restoration?

Q2 Answer: within the Riverine Woodland/Aldermoor complex along the stream the recovery of the vegetation is impressive, despite the extensive disturbance of the works and access way. The vegetation of disturbed and undisturbed adjacent areas are now difficult to distinguish and only slight species differences could be detected occasionally. The speed of this recovery is remarkable and appears to reflect a degree of resilience within the habitat that the author had not fully appreciated. This probably reflects the dynamism of the floodplain habitat. On a brief look at the upstream works, this recovery is much faster than the recovery of the upstream Wet Lawn habitats. Here, although clearly well on the way to recovering, the access routes can still easily be determined from the vegetation.

Q3a: have the stream restoration works, particularly the machinery movements through the woodland and the placement of hoggin, caused irreparable damage to the SSSI?

Q3a Answer: no irreparable damage to the SSSI vegetation could be detected in this survey.

Q3b: has the hoggin used on the access route has created an impermeable layer that will compromise the integrity of the site?

Q3b Answer: there is a substantial amount of hoggin left on site as a now buried access way. As far as could be observed by this walk over survey this access way is now buried below the water at the time of survey, so the water will normally flow over it. There was ponding of water at the surface at the time of survey across the mire well away from the access way to the north and this appears the normal condition of the mire when wet. The mire is naturally ponded against the stream levee, so flow is probably mainly on the surface anyway.

Q3c: where possible, assess the soil profile from points along the 'access route' and in adjacent areas, to assess whether the natural soil profile has been lost or altered irreparably.

Q3c Answers: the natural soil profile has been lost irreparably along the access route but this has had surprisingly little influence on the vegetation, which is responding to the surface water and soil conditions not the depth of the peat.

A copy of the report will be provided to Mrs Tear and be made publicly available.

[question from previous presentment] What was the original quote for that element of the project and what was the final cost?

The quote for operating costs (including VAT) to carry out all the works under the Pondhead HLS Wetland Restoration Project (Planning Application Number 15/00294) was £255,567. A separate breakdown of costs for this element of the project was not required as part of the quote.

By the end of 2019, the final operating cost (including VAT) for implementing the full Pondhead HLS Wetland Restoration Project, not just the section in question, was £253,062.

#### ANIMAL ACCIDENT REPORT

## 2020/11273 THE ANIMAL ACCIDENT REPORT FOR SEPTEMBER 2020

The Agisters attended 13 accidents in September, compared with 12 in the same period last year.

- 2 ponies, 2 cattle and 1 pig died and 1 pony and 2 cattle were injured.
- 1 of the ponies which died was wearing a reflective collar.
- 2 accidents occurred in daylight, 3 at twilight and the other 8 in the dark.
- 2 drivers failed to report having been involved in an accident.

The total killed and injured to the end of September was 44, compared with 67 in the same period last year.

## PRESENTMENTS BY THE DEPUTY SURVEYOR

## 2020/11274 PANNAGE SEASON EXTENSION 2020

Following requests from both the Commoners' Defence Association and the Verderers, I can announce that I have agreed to an extension of the pannage season this year in response to the quantities of fallen acorns present this autumn.

The pannage season will now close on Monday 21 December 2020, an extension of 36 days. All pigs must be removed from the Forest by this revised end date.

Breeding sows, that is pigs in pig, may be allowed the privilege of remaining on the Open Forest after the end of the pannage season but only if authorised in writing by the Deputy Surveyor for the period specified in the consent.

## 2020/11276 THE VERDERERS DECISION NOT TO MARK CATTLE

Presentment by:-

Ms Debbie Stokes – Practicing Commoner and Cattle Owner Robert Stride – Practicing Commoner and Cattle owner Mrs Charlotte Lines - Practicing Commoner

We would like to commend the Verderers and Agisters on their professional and Covid safe approach to the pony drifts this season. We are however at a loss to understand why these now established protocols cannot be applied to cattle marking, which is equally important as pony welfare. It is disappointing that that there was no consultation with cattle owners before the decision was made.

The marking of cattle requires only the owners and the Agister to be present, as well as the Vet if carried out in conjunction with the annual TB test. Social distancing is possible and the procedure on most holdings is undertaken outside.

We are concerned that the cattle will not be subject to the same welfare checks as the ponies. It is imperative that the Agister assesses both the temperament and condition of the cattle at close quarters before they are approved for turnout. In addition, it also gives new cattle owners the opportunity to seek expert advice from the agisters. If cattle will not be marked, what new procedures have the Verderers put in place to ensure only healthy animals are turned out?

#### We ask that the Court:

- Re-considers the decision not to mark cattle for 2021.
- 2. If this decision is not reversed, we ask that the Verderers identify mitigating actions to ensure only animals meeting the DEFRA condition standards are turned out.
- Provides reassurance to commoners that this will not be a long-term change and that the traditional role of the Agister as marksman is maintained.

#### 2020/11278 MARKING CATTLE

**DISCHARGE** 

Mr Manley suggested the decision not to mark cattle for 2021 should be reviewed and Mr Deakin welcomed the opportunity to discuss it further.

The presentment was received from the three commoners listed. It is not made on behalf of the CDA.

The Covid-19 situation is deteriorating and the Court feels that unfortunately it is likely to get worse as the winter progresses. After much discussion in the Staff Committee, the decision was made not to mark cattle this year because of the potential risk to the health and safety of the Agister team. Relevant factors include the conditions on commoners' holdings where some have better cattle handling facilities than others and how much assistance a commoner requires. It is felt, however, that it would not be fair or reasonable to discriminate on the basis of what facilities are available or how much Agister help might be needed.

Making a comparison with the drifts, whilst understandable, isn't really appropriate because on the drifts, the Verderers and Agisters have control

of the pound and full PPE is made available every time. On a private holding, control is much more limited.

As respects ensuring cattle are only turned out when their condition is acceptable, it was pointed out that in some cases, many weeks pass between the day they are marked and the day they are turned out. Mr Deakin pointed out that this spring, some cattle were turned out looking well but they then lost condition and had to be taken back in.

The question of whether the Agisters should visually check cattle before they go out was also discussed. Mr Greenwood felt very strongly that cattle should be inspected by the Agister before they are depastured. In the end, it was agreed that Agisters patrolling their areas inspect the stock on the Forest as part of their everyday duties and any animals found to be below an acceptable standard will be removed.

Subject to the consideration of any counter presentments at the November Court, the decision not to mark cattle for 2021 is upheld.

This is not intended to be a long-term decision and we very much hope that it will be possible to return to normal for 2022.

The Clerk reported that significant problems are now being experienced with most of the vehicles suffering serious defects. Organising recovery of broken-down vehicles and the supply of loan vehicles (in accordance with the contract) is proving to be complicated and very time consuming due to the appalling service now being received from SHB, which has been taken over by Enterprise.

The current lease-hire agreement does not expire until early 2022 and in view of the difficulties being experienced, it was agreed a sub-committee consisting of Mr Readhead, Mr Dowsett and the Clerk should look at the possibility of ending the contract early. The sub-committee will make a recommendation as to the best way forward.

## NEW SUBMISSIONS AND OTHER MATTERS RAISED BY FORESTRY ENGLAND

2020/11285 RENEWAL OF THE CROWN LANDS WAYMARKED CYCLE NETWORK

RESUME

An application for the renewal of the Verderers' consent for the Waymarked Cycle Network for a further two years has been received from Forestry England.

Mr Pasmore drafted a paper, in which he again raised the continuing and widespread issue of off-track cycling and the lack of any enforcement. He suggested a possible way forward for FE to invoke its byelaw which forbids cycling on the Forest except on the waymarked cycle network.

The Court supported Mr Pasmore's argument that something needs to be done to control off-track cycling which is out of control. Members of the Court expressed their frustration at the apparent lack of action on behalf of FE and it was widely agreed that without an action plan for tackling the problem, the Court will be very reluctant to consent to the continuation of the waymarked cycle network.

In response, the Deputy Surveyor agreed there has been a significant escalation in off-track cycling, particularly this year when the public were encouraged to exercise locally during the pandemic restrictions.

The Deputy Surveyor went onto say there may be opportunities through mitigation funding to bolster the staff resources which are essential if the varying issues affecting the Forest are to be satisfactorily tackled. This is yet to be tested as an appropriate call on these funds which are deployed by the relevant Planning Authority.

The Court decided to hold back any decision on renewing its consent for the Waymarked Cycle Network until the November Court. Meanwhile FE will prepare a plan for a focussed campaign to intercept off-track cycling.

# MATTERS ARISING FROM MINUTES OF PREVIOUS COURTS OF CONCERN TO FORESTRY ENGLAND

2020/11286 COMMERCIAL DOG WALKING

RESUME January 2021

The Deputy Surveyor said FE is continuing to look at options for how it could licence commercial dog walkers. He is hopeful a way forward will be clearer shortly. It was agreed that there are some very good dog walkers but also

some who just arrive in a car park and release a pack of dogs which are allowed to run amok, causing various problems. It is agreed that a licencing system will have a number of advantages, including ensuring that licensees have relevant insurance and place a limit on the number of dogs that they can reasonably be expected to control. This will benefit dog owners as they will be confident their walker is responsible. It will also benefit the Forest by ensuring there are fewer out of control dogs.

## 2020/11287 BURLEY GOLF CLUB LICENCE RENEWAL

The Golf Club has made some requests for changes to the course. Therefore, before a new licence can be approved, a site meeting will be needed. Mr Grugeon was asked to arrange this.

There is concern that there are increasing pressures on the Forest Sports Clubs to become commercial and to compete with private facilities. The result can be that they become significantly more detrimental to the Forest than they are currently. Whilst it is understood the income from Sports Club licences is of significant interest to FE and it may provide for additional Forest management resources, the effects on the Forest of intensification of use by Sports Clubs is not beneficial to the Forest.

## 2020/11288 BROOMY PLAIN ROAD PASSING PLACE SIGNAGE

RESUME

The HCC Road Safety Audit Stage 3, made the recommendation to continue to monitor the scheme and did not stipulate that signage is needed on each passing place. Members of the Court are concerned at the detrimental impact signage will have on the landscape, particularly as such signs have to meet Dept of Transport specification. Concern was also expressed that the provision of signs might encourage drivers to race to the next passing place and thereby actually increase the risk of collision, whether with other vehicles or potentially Forest stock.

One suggested solution is signs at each end of the scheme advising motorists that there are passing places ahead at regular intervals and a post with reflectors at each passing place. It was agreed a site meeting should be requested with Mr Martyn Milner of HCC. Mr Dowsett and Cllr Heron will attend for the Court, together with Mrs Jayne Albery from FE.

## 2020/11289 BT PROPOSAL FOR THE PROVISION OF BROADBAND FIBRE SPINE AT EAST END

The Clerk advised BT that the Court cannot approve a proposal that includes a large number of new poles without a presentment. This communication was acknowledged but nothing further has subsequently been heard.

Cllr Heron has obtained per metre costings for the various options and it is clear that putting a duct under a metalled highway is extremely expensive.

The Court is unsure whether the suggested option to place the duct under the verge has actually been pursued with Natural England. Mrs Westerhoff offered to ask NE if it has been asked about that option.

The Official Verderer said he would like to ask Defra to draft two new byelaws, one stipulating the minimum age calves may run on the Forest and the other concerning the minimum age that young animals without their mothers may be on the Forest. The latter byelaw is felt to be non-contentious.

A detailed discussion took place regarding the minimum age for calves with differing views being expressed. If passed, such a byelaw would have a significant effect on how some commoners manage their herds. This has to be balanced against the risk to the public from cows with baby calves, when the cows can be very protective. It is noted that some commoners

have already taken steps to alter their herd management to avoid calving on the Forest. Others have found that very difficult to achieve.

At this point the Court adjourned for lunch.

Mrs Westerhoff, Mr Greenwood and Mr Readhead gave their apologies as they were unable to return to the meeting.

The Official Verderer asked for a show of hands by those in favour of the principles behind the proposed byelaw and of asking Defra to proceed with drafting the revised byelaws. Mr Deakin, Mr Greenwood, Cllr Heron, Mr Pasmore and the Official Verderer all indicated they would like Defra to proceed. Mr Manley voted against. Once the wording of the byelaw has been finalised a further debate can take place to decide whether to proceed with formal consultation.
