2025/14369 CANADIAN FLAGS IN THE VERDERERS HALL

The Court is pleased to welcome Lieutenant Colonel Montgomery Price and Warrant Officer Christopher Astley this morning.

Last November Forestry England and the Verderers were presented with two flags on Remembrance Day by officers of the Canadian armed forces to both commemorate the 80th anniversary of D Day and in thanks for the continued care of the Canadian Cross Memorial. These flags will now be kept for safe keeping here at the Kings House.

The Verderers would like to thank both Mr Andy Shore and Mr Keith Mansbridge for their commitment in looking after the Memorial and for sourcing the oak which was used to make the flag poles and stand respectively.

We would also like to thank Mr Kevin Gray for his time and skill in making them.

The citation from the Canadian Army division who were encamped on the Forest is placed on the wall here at the Court

2025/14370 MARKING FEES 2026

For 2026 the marking fees will be: -

Ponies, Cattle and Donkeys £29.00 per head.

Sheep £12.00 per head

Pigs £5.00

The concessionary marking fees for animals depastured on the adjacent commons ceases with the end of the Commons Agreement at the end of December this year.

Please remember that marking fees are due from the 1st of January. Under our Byelaws, the deadline for payment of all marking fees for continuously depastured animals is 31st March.

If not paid by 31st March, you will not be eligible to join the Verderers Grazing Scheme. Marking fees for animals which are not continuously depastured are due before the animals are turned out. It is the responsibility of commoners to volunteer payment of marking fees, not the responsibility of the Agister to chase you for them.

2025/14371 TWO-YEAR-OLD COLTS

We would like to remind commoners that the Verderers' Byelaws require uncastrated colts which were born in 2024 or earlier, to be removed from the Forest by 1st February 2026.

If such a colt is found to be on the Forest after 1st February next year, the owner will be in breach of the Verderers' byelaws and could be prosecuted. In addition, any owner in breach of the Verderers' byelaws may forfeit some or all of their Verderers' Grazing Scheme entitlement.

2025/14372 FORESTRY ENGLAND CAR PARKING CHARGES

The Court shares the CDA's wish to see any revenue raised by Forestry England from their introduction of car parking charges remain within the Forest. The Deputy Surveyor has assured the Court that the funds raised will go directly into the budget that he manages for the New Forest and that it is hoped that some additional funding will be used for projects that benefit Commoning.

2025/14373 1964 COMMONS AGREEMENT

The Court thanks Mr Langdown for his Presentment and the opportunity this gives to reassure Commons Commoners that the end of the agreement, while meaning that the end of the reduction in marking fees, does not in any way alter their rights to depasture livestock on the Commons. Commoners with rights over the Northern Commons can continue to depasture stock in accordance with their rights, as they do currently, provided of course that marking fees are paid.

TREE BARKING BY PONIES

Three of the ponies identified by the Agister team as beech barking have been voluntarily removed from the Forest by their owners.

The Commoners Defence Association will be placing mineral licks in strategic locations to see if the licks deter future damage to beech trees.

Forestry England have carried out some fencing repairs which have kept ponies out of the affected inclosures over the summer months.

The Court will continue to monitor the situation closely.

THE ANIMAL ACCIDENT REPORT

2025/14374 THE ANIMAL ACCIDENT REPORT FOR OCTOBER 2025

The Agisters attended 14 accidents in October, compared with 16 in October last year.

3 ponies and a donkey were killed. 3 ponies were injured, 1 pony escaped injury and in 6 instances the animals reportedly involved in an accident could not be found.

4 of the accidents happened in daylight, 2 at twilight and 8 in the dark.

1 driver has failed to report having been involved in a collision with a Forest animal.

The total number of commoners' animals killed and injured this year is 40 which is the same number as at the end of October 2024.

PRESENTMENTS BY THE DEPUTY SURVEYOR

2025/14375 CANADIAN FLAGS IN THE VERDERERS HALL

"I am delighted that Lieutenant Colonel Montgomery Price and Warrant Officer Christopher Astley from the Canadian Army are with us today in court. New Forest oak from the Crownland Inclosures has been used to create the wonderful poles & plinth for the flags. I'd also like to thank Keith Mansbridge and Kevin Grev for making this happen.

In 1944 the 3rd Canadian Division were camped in Highland Water Inclosure before the Normandy invasion. Church services were held at Mogshade Hill using a simple pine cross and flag covered alter.

A memorial was first erected in 1949 and has been maintained and refurbished since then. The cross that stands there now is still held together by the original bolt used in 1944.

Forestry Commission & England have been tending the site since that time, in recognition of the importance of that moment. I'd like to thank Andy and Sandy Shore for their help maintaining the memorial site over the years and attending Remembrance Day services with their family.

The presence of these flags in Verderers Hall and their use on Remembrance Day are a fitting reminder of the actions and bravery of the 3rd Canadian Infantry Division. We will always remember and thank all Allied troops based in the New Forest who helped secure the freedoms we enjoy today."

That sincere hospitality from the community of New Forest was as a soothing balm to the soldiers, prior to their seeing combat.

You have continued to remember and mark the Canadian contribution, and, for that, we are truly grateful.

On behalf of Canada, I would like to offer my sincere thanks. Merci infiniment."

PRESENTMENTS BY THE PUBLIC

2025/14377 CAR PARKING REVENUE Presentment by Sarah Nield, Chair of the New Forest Association

"Official Verderer and Verderers and the members of public attending court today, I am Sarah Nield, Chair of the New Forest Association (NFA). I am giving this presentment following the Court's September decision relating to the introduction of car parking charges.

We note from the Court's minutes that consent was given subject to conditions. We would like to highlight the importance of these conditions as well as implications of certain Forestry England's representations given to the Court.

One condition is that FE "are to confirm that they are legally able to enforce parking restrictions." Regulatory powers are important because the stronger they are the less the need for physical measures. Furthermore, all parking consultants I have spoken to emphasise the need for early and robust enforcement of parking controls to send a clear message. There is no doubt that FE can fine visitors who do not pay to park in designated car parks. Our concern is what powers are there to stop verge parking on both FE managed land and the adjacent commons? The FC Byelaws are largely unhelpful unless amended and, in any event, have been rarely enforced nor do they extend beyond FE managed land. Other possibilities, which we understand the Verderers have explored in the past, include Traffic Regulations Orders or a PSPO against verge parking. But both would require local authorities' co-operation.

Physical measures include ditching and dragon's teeth which the Verderers reiterate will require their and Natural England's approval. Both these mitigation measures bring their own environmental and aesthetic issues. For example, recent ditching between Matley and Lyndhurst has caused environmental damage and is now undermining the road – see attached photograph. We hope the Verderers will keep these in mind when considering any ditching proposals particularly when dragon's teeth could do the job.

Displacement parking is likely to affect neighbouring landowners, forest villages and settlements. The Verderers proposal for a memorandum of understanding with 'significant landowners' is thus welcome, but does it go far enough? We urge FE's engagement with parish councils and support for smaller landowners affected by displacement parking.

Now turning to the money which we appreciate the Verderers cannot directly influence. Nevertheless, visitors are less likely to park on verges where charges are reasonable and where they know the money will go the Forest. We thus are disappointed that there are no plans for a reasonably priced local parking permit unlike other FE managed forest such as the Forest of Dean or the Forest of Bere. The only annual permit offered is a national membership permit at £96 although local users may rarely visit other FE car parks nor wish to become FE members! We also join the CDA, NFDOG and others in seeking assurance that the money stays in the Forest and the Verderers' minutes record FE's assurances to that effect. But how is this to be achieved? We believe that the safest mechanism is by way of hypothecation to ring fence this income from other FE funds. So, in short, we urge the Verderers to stick rigidly by their consent conditions and insist that FE have robust regulatory and physical mitigation measures to protect against verge parking across the Forest and to ensure that only the Forest benefits from this income."

2025/14378 COUNTY PARISH HOLDING (CPH) NUMBERS Presentment by Immy Bickford-Smith

"Good morning. My name is Immy Bickford-Smith.

As most of you will know a CPH number is a nine-digit number consisting of two digits for the County - 3 digits for the Parish and 4 digits for the individual holding. It is a unique identifier required for land or buildings used to keep livestock, for farmers the main gathering point on their farm or main field.

CPH numbers are allocated by the Rural Payments Agency (RPA) and RPA states: "Having an accurate CPH number ensures that the government knows where your livestock are kept and can trace them to help prevent and control disease, something that is a requirement of all livestock keepers."

CPH numbers are especially important in the New Forest where multiple large herds of cattle mix on common land. And those cattle may also have contact with additional herds of cattle over fences on privately owned fields.

Therefore, accuracy of New Forest CPH numbers is vital. However, there is reason to believe there may be a problem.

My CPH number was given to me by the RPA in 1994. Earlier this year I acquired another bit of land adjacent to my holding that for many years I had grazed on a Temporary Land Association arrangement (TLA).

I contacted RPA to add this extra land to my CPH and was told by RPA that because I had 'moved Parish' I would have to have a new CPH number. I explained that I had not moved Parish. My home and land had not moved, and I was in the same Parish (the Parish of Ellingham) that I was in when the RPA gave me this CPH number in 1994. The additional land is also in the same Parish. But RPA insisted my holding was "in the wrong Parish" and my CPH number had to be changed because the number for Ellingham Parish is 239 and the Parish number I had been given originally was for another Parish.

An accurate CPH number is compulsory.

The change involved notification to APHA, BCMS and Farm Care. Unfortunately, this was not straight forward and resulted in further issues but those were eventually resolved.

Unfortunately, the RPA was not interested to know if there were other inaccurate CPH numbers here, but I'd soon found at least two inaccurate numbers in this Parish alone.

Concerns have already been raised in the National farming press about bovine TB cases that have exposed flaws in the government/RPA's cattle tracing system.

Over the past 20 years the RPA implemented unique subsidy schemes for the New Forest based on headage payments and this actively encouraged unprecedented and unsustainable numbers of stock onto the common land.

Accurate CPH numbers and details of TLAs attached to those CPH numbers is essential for effective traceability of stock – and especially important for those animals using common land.

The lack of relevant information to implement an efficient and effective disease control plan could jeopardise the future of farming in the New Forest. And it is not only the health and welfare of commoner's stock at risk but also the stock owned by farmers – and of course the significant wildlife here.

Please can the Verderers provide their assurance that they do already hold CPH and TLA information for all active common land graziers and that the accuracy of the Parish sections of the CPH numbers has been verified?

And with reference to future New Forest subsidy scheme(s) may I suggest that transparency of CPH and TLA details should be a condition of receipt of any subsidy or financial benefit."

Mr Pasmore, Miss Harrison and Mrs Tilbury gave a report on the meeting they had with Mr Richard Burke of FE. The minutes from the meeting have not yet been received from Mt Burke and there are unresolved queries which require further discussion.

The Deputy Surveyor said he was still waiting for legal advice relating to verge parking enforcement. Mr Pasmore said both he and the New Forest Association have asked for copies of the advice once received.

The Official Verderer said that an update from Forestry England will be beneficial. The Deputy Surveyor is asked to provide a formal update to the Court as soon as one is available.

The Official Verderer said he had been approached by the club's chairman requesting a meeting which he has declined.

Mr Adderley said the outfield gates have been opened and the area is currently being grazed by commoners' animals. It has been explained to the club that they will forfeit their licence if they do not comply with the terms applied.

Mr Adderley said Cadnam Cricket Club have never had a management plan in place with Natural England and the one held by the sister club in Minstead is due to expire soon.

Mr Stride read a report to the Court, supplied by Mr Richard Deakin in his absence.

The Court states that all the issues at both Minstead and Cadnam Cricket Clubs must be resolved, and the club must have a Management Plan in place with Natural England before February. Failure on the club's part to do this may result in the Verderers withdrawing their consent for the club's license with Forestry England.

Mr Pasmore said the crossing at Newlands is again in a terrible state. He said it is the only crossing between Rockford and Ibsley Commons and is now dangerous to horse riders. Mr Stride said the National Trust have repaired it in the past, but it has deteriorated again.

The Official Verderer said he will go and look at the crossing and send emails to the National Trust and Hampshire County Council before the next Court.
